

## **Conditions of Participation**

1. Before using the climbing park all participants are requested to read these rules carefully and confirm his/her agreement to follow the rules by signing below. For our visitors who are under 18 years of age a legal guardian should read and explain the conditions to the the underage person and confirm that they have fully understood the rules by signing below.
2. The participant should be aware that there are dangers involved with climbing and accepts that using the park is at his/her own risk. Every participant must decide about the intensity and extent of his physical activities. Failure to apply the correct safety techniques can result in serious injury or death. See paragraph No. 9 concerning the liability of the company Freudhofmaier KG.
3. Smoking is strictly prohibited within the whole area of the climbing park (with the exception of the Smokers´ Corner). While wearing the safet equipment it is strictly forbidden to smoke or approach lit cigarettes or fire!
4. The minimum height for using the climbing park is 110 cm. The maximum weight is 120 kg. Children under the age of 14 are only allowed to enter the climbing park in the company of an adult. A further condition for access to the climbing park is that the participant is free from any disease or any physical or mental handicap that could endanger his/her own health or that of another visitor. People who are under the influence of alcohol or drugs are not allowed to use the climbing facilities.
5. While you are climbing, objects such as mobile phones, watches or jewelry should be kept in a safe place, so as not to present any danger to the climber or any other person. Long hair should be tied up or secured under the helmet.
6. Before using the climbing park every visitor has to take part in the theoretical and practical safety training. Any instructions or decisions of the organiser or staff are binding. Breaking the rules or offending against the safety instructions of the organiser or staff may result in exclusion from the climbing park. The company Freudhofmaier KG accepts no liability for any damage caused by violating the safety rules or instructions of the staff.
7. The borrowed equipment (helmet, climbing harness, safety rope and carabiner, steel cable roll) has to be used according to the instructions of the organiser or staff. The equipment is the property of the organiser and has to be returned in its entirety to the return point before leaving the park. For your own safety, the equipment must not be taken off while you are using the climbing facilities.
8. Both safety carabiners have to be fixed to the steel rope (red safety rope) facing in opposite directions. When moving one carabiner must always

remain fixed to the red safety rope. Please note, that you should never under any circumstances remove both carabiners from the safety rope. The steel cable roll must be attached to the green safety rope (Flying Fox). Before proceeding onto the Flying Fox path make sure that both the flight path and the termination point are clear.

9. The company Freudhofmaier KG shall be liable for injury to persons pursuant to the statutory provisions. The liability of the company Freudhofmaier KG to claims for damages to property or property loss are limited to cases of premeditation or gross negligence of the organiser or staff that have been entrusted by the organiser with management and control.
10. Children may only use the high rope courses according to the age and body height limits. Each climbing exercise must only be used by one person at a time. The maximum number of persons on a platform is three.
11. The company management reserves the right to exclude persons from the park, who offend against the rules of participation. The company management also reserves the right to shut down the park for safety reasons (e.g. fire, thunder storm, gales,...). In such a case the entry fee will not be refunded. If a visitor decides to leave the park prematurely on his own initiative the entry fee will also not be refunded.
